TRACE COMPONENTS: Trace ingredients (if any) are present in < 1% concentration, (< 0.1% for potential carcinogens, reproductive toxins, respiratory tract mutagens, and sensitizers). SECTION 4: First aid measures

4.1 Most Important Symptoms/Effects, Acute and Chronic

4.2 General Advice

First Aid responders should pay attention to self-protection and use the recommended protective clothing (chemical resistant gloves, splash protection). If potential for exposure exists, refer to Section 8 for specific personal protective equipment.

4.3 Eye Contact

If this product enters the eyes, check for and remove any contact lenses. Open eyes while under gently running water. Use sufficient force to open eyelids. "Roll" eyes to expose more surface. Minimum flushing is for 15 minutes. Seek immediate medical attention.

4.4 Skin Contact

If the product contaminates the skin, immediately begin decontamination with running water. Minimum flushing is for 15 minutes. Remove contaminated clothing, taking care not to contaminate eyes. If skin becomes irritated and irritation persists, medical attention may be necessary. Wash contaminated clothing before reuse, discard contaminated shoes.

4.5 Inhalation

After high vapor exposure, remove to fresh air. If breathing is difficult, give oxygen. If breathing has stopped, trained personnel should immediately begin artificial respiration. If the heart has stopped, trained personnel should immediately begin cardiopulmonary resuscitation (CPR). Seek immediate medical attention.

4.6 Swallowing

4.7 Rescuers

4.8 Notes to Physician

There is no specific antidote. Treatment of overexposure should be directed at the control of symptoms and the clinical condition of the patient. Any material aspirated during vomiting may cause lung injury. Therefore, emesis should not be induced mechanically or pharmacologically. If it is considered necessary to evacuate the stomach contents, this should be done by means least likely to cause aspiration (such as: Gastric lavage after endotracheal intubation).

SECTION 5: Firefighting measures

5.1 Fire and Explosion Preventive Measures

NO open flames, NO sparks, and NO smoking. Use a closed system, ventilation, explosion-proof electrical equipment, lighting. Do NOT use compressed air for filling, discharging, or handling.

5.2 Suitable (and Unsuitable) Extinguishing Media

Use dry powder, AFFF, alcohol-resistant foam, water spray, carbon dioxide.

5.3 Special Protective Equipment and Precautions for Fire Fighters

Water spray may be ineffective on fire but can protect fire-fighters and cool closed containers. Use fog nozzles if water is used. Do not enter confined fire-space without full bunker gear. (Helmet with face shield, bunker coats, gloves and rubber boots).

SECTION 6: Accidental release measures

6.1 Spill and Leak Response and Environmental Precautions

Uncontrolled releases should be responded to by trained personnel using pre-planned procedures. No action shall be taken involving personal risk without suitable training. Keep unnecessary and unprotected personnel from entering spill area. Do not touch or walk through material. Avoid breathing vapor or mist. Provide adequate ventilation. Proper protective equipment should be used. In case of a spill, clear the affected area, protect people, and respond with trained personnel. ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area).

6.2 Personal Precautions, Protective Equipment, Emergency Procedures

The proper personal protective equipment for incidental releases (such as: 1 Liter of the product released in a well-ventilated area), use impermeable gloves, they should be Level B: triple-gloves (rubber gloves and nitrile gloves over latex gloves), chemical resistant suit and boots, hard-hat, and Self-Contained Breathing Apparatus specific for the material handled, goggles, face shield, and appropriate body protection. In the event of a large release, use impermeable gloves, specific for the material handled, chemically resistant suit and boots, and hard hat, and Self-Contained Breathing Apparatus or respirator.

Personal protective equipment are required wherever engineering controls are not adequate or conditions for potential exposure exist. Select NIOSH/MSHA approved based on actual or potential airborne concentrations in accordance with latest OSHA and/or ANSI recommendations.

6.3 Environmental Precautions

Stop spill at source. Construct temporary dikes of dirt, sand, or any appropriate readily available material to prevent spreading of the material. Close or cap valves and/or block or plug hole in leaking container and transfer to another container. Keep from entering storm sewers and ditches which lead to waterways, and if necessary, call the local fire or police department for immediate emergency assistance.

6.4 Methods and Material for Containment and Clean-Up

Absorb spilled liquid with polyops or other suitable absorbent materials. If necessary, neutralize using suitable buffering material, (acid with soda ash or base with phosphoric acid), and test area with litmus paper to confirm neutralization. Clean up with non-combustible absorbent (such as: sand, soil, and so on). Shovel up and place all spill residue in suitable containers. Dispose of at an appropriate waste disposal facility according to current applicable laws and regulations and product characteristics at time of disposal (see Section 13 - Disposal Considerations).

6.5 Notification Procedures

In the event of a spill or accidental release, notify relevant authorities in accordance with all applicable regulations. US regulations require reporting release of this material to the environment which exceed the applicable reportable quantity or oil spills which could reach any waterway including intermittent dry creeks. SECTION 7: Handling and storage

7.1 Precautions for Safe Handling

Isolate from oxidizers, heat, sparks, electric equipment and open flames. Use only with adequate ventilation. Avoid breathing of vapor or spray mist. Avoid contact with skin and eyes. Consult Safety Equipment Supplier. Wear goggles, face shield, gloves, apron and footwear impervious to material. Wash clothing before reuse. Avoid free fall of liquid. Ground containers when transferring. Do not flame cut, saw, drill, braze, or weld. Empty container very hazardous! Continue all label precautions!

7.2 Conditions for Safe Storage, including any Incompatibilities

Vapors may ignite explosively and spread long distances. Prevent vapor buildup. Put out pilot lights and turn off heaters, electric equipment and other ignition sources during use and until all vapors are gone. Keep in fireproof surroundings. Keep separated from strong oxidants, strong acids, strong bases. Keep cool. Do not store above 49 C / 120 F. Keep container tightly closed and upright when not in use to prevent leakage. Do not allow to evaporate to near dryness. Addition of water or proper reducing agents will lessen peroxide formation.

7.3 Nonbulk: Containers

Store containers in a cool, dry location, away from direct sunlight, sources of intense heat, or where freezing is possible. Material should be stored in secondary containers or in a diked area, as appropriate. Store containers away from incompatible chemicals (see Section 10, Stability and Reactivity). Post warning and "NO SMOKING" signs in storage and use areas, as appropriate. Empty containers should be handled with care. Never store food, feed, or drinking water in containers which held this product.

7.4 Bulk Containers

All tanks and pipelines which contain this material must be labeled. Perform routine maintenance on tanks or pipelines which contain this product. report all leaks immediately to the proper personnel.

7.5 Tank Car Shipments

Tank cars carrying this product should be loaded and unloaded in strict accordance with tank-car manufacturer's recommendation and all established on-site safety procedures. Appropriate personal protective equipment must be used (see Section 8, Engineering Controls and Personal Protective Equipment). All loading and unloading equipment must be inspected, prior to each use. Loading and unloading operations must be attended, at all times. Tank cars must be level, brakes must be set or wheels must be locked or blocked proper to loading or unloading. Tank car (for loading) or storage tanks (for unloading) must be verified to be correct for receiving this product and be properly prepared, prior to starting the transfer operations. Hoses must be verified to be in the correct positions, before starting transfer operations. A sample (if required) must be taken and verified (if required) prior to starting transfer operations. All lines must be blown-down and purged before disconnecting them from the tank car or vessel.

7.6 Protective Practices during Maintenance of Contaminated Equipment

Follow practices indicated in Section 6 (Accidental Release Measures). Make certain application equipment is locked and tagged-out safety. Always use this product in areas where adequate ventilation is provided. Collect all rinsates and dispose of according to applicable Federal, State, Provincial, or local procedures.

7.7 Empty Container Warning

Empty containers may contain residue and can be dangerous. Do not attempt to refill or clean containers without proper instructions. Empty drums should be completely drained and safely stored until appropriately reconditioned or disposed. Empty containers should be taken for recycling, recovery, or disposal through suitably qualified or licensed contractor and in accordance with governmental regulations. 8.2 Appropriate Engineering Controls

8.2.1 RESPIRATORY EXPOSURE CONTROLS

Airborne concentrations should be kept to lowest levels possible. If vapor, dust or mist is generated and the occupational exposure limit of the product, or any component of the product, is exceeded, use appropriate NIOSH or MSHA approved air purifying or air-supplied respirator authorized in 29 CFR 1910.134, European Standard EN 149, or applicable State regulations, after determining the airborne concentration of the contaminant. 8.3 Individual Protection Measures, such as Personal Protective Equipment

8.3.1 EYE PROTECTION:

Safety eyewear complying with an approved standard should be used when a risk assessment indicates this is necessary to avoid exposure to liquid splashes, mists or dusts. If contact is possible, chemical splash goggles should be worn, when a higher degree of protection is necessary, use splash goggles or safety glasses. Face-shields are recommended when the operation can generate splashes, sprays or mists.

8.3.2 HAND PROTECTION:

SECTION 10: Stability and reactivity

10.1 Reactivity and Chemical Stability

Stable under normal conditions, no hazardous reactions when kept from incompatibles.

10.2 Possibility of Hazardous Reactions and Conditions to Avoid

Isolate from oxidizers, heat, sparks, electric equipment and open flame.

10.3 Incompatible Materials

The substance can presumably form explosive peroxides, under the influence of light and air. Check for peroxide prior to distillation, eliminate if found. Reacts violently with strong oxidant, strong reduction agents, strong acids, strong bases, causing fire and explosion hazard. Attacks many plastics, rubber, coatings.

10.4 Hazardous Decomposition Products

SECTION 11: Toxicological information

11.1 Acute Hazards

11.1.1 EYE AND SKIN CONTACT

Primary irritation to skin, defatting, dermatitis. Absorption thru skin increases exposure. Primary irritation to eyes, redness, tearing, blurred vision. Liquid can cause eye irritation. Wash thoroughly after handling.

11.1.2 INHALATION

Anesthetic. Irritates respiratory tract. Acute overexposure can cause serious nervous system depression. Vapor harmful. Acute overexposure can cause harm to affected organs by routes of entry. Use of alcoholic beverages enhances the harmful effect.

11.1.3 SWALLOWING

ASPIRATION HAZARD! Harmful or fatal if swallowed. Do NOT induce vomiting. If spontaneous vomiting occurs, keep victim's head below the waist to prevent aspiration. Swallowing can cause abdominal irritation, nausea, vomiting and diarrhea. The symptoms of chemical pneumonitis may not show up for a few days.

11.2 Subchronic Hazards/Conditions Aggravated

MEDICAL CONDITIONS AGGRAVATED BY EXPOSURE:

Pre-existing disorders of any target organs mentioned in this Document can be aggravated by over-exposure by routes of entry to components of this product. Persons with these disorders should avoid use of this product.

11.3 Chronic Hazards

11.3.1 CANCER, REPRODUCTIVE AND OTHER CHRONIC HAZARDS

Pregnant women should avoid use. May cause birth defects. Potential Cancer Hazard based on tests with laboratory animals using Methyl Isobutyl Ketone and Ethylbenzene. Overexposure may create cancer risk. Leukemia been reported in humans from Benzene. This product contains less than 57 ppm of Benzene. Not considered hazardous in such low concentrations.
